How to Avoid Paying Interest on Purchases	Your due date is at least 25 days after the close of each billing cycle. We will not charge you interest on purchases if you pay your entire account balance, including balance transfers and cash advances, by the due date each month. We will begin charging interest on cash advances and balance transfers on the transaction date.

Not all applicants will qualify for the lowest rate. **Balance Transfers:**² This transaction is subject to credit approval. **Loss of Balance Transfer APR:** We may end your Balance Transfer APR and apply the Penalty APR if we do not receive your payment within 60 days of the due date. **Pathfinder Rewards:** Cash advances, credit card checks, balance transfers or account fees are excluded from cash rewards. There is no minimum or maximum amount of reward you may receive. If your account is closed, any accrued reward is forfeited. PenFed reserves the right to modify these programs at any time. **Other Notes:** There is a \$1.00 fee for each paper statement received. Electronic statement notification is free.
