Scott and other winners in NAFCU's 2014 Annual Awards Competition will be honored in conjunction with NAFCU's 47th Annual Conference and Solutions Expo in Las Vegas, July 22-26.

“Scott has been a loyal and valuable asset to PenFed’s board of directors and the credit union movement for over 28 years. Annual Awards Competition winners will be celebrated during the conference’s general session and breakfast July 25, and profiled in an upcoming issue of The Federal Credit Union magazine.
